- Do you have dogs?
- Should the Registration Officer bring gumboots?
- Which door should the Registration Officer come to and do you have a “shoes off” policy inside?
- Do you have any Covid concerns e.g. have the visit outside?

If your child has a diagnosed medical condition which affects the delivery of a program, you may be required to provide information about the diagnosis and subsequent treatment, only where it is relevant to the delivery of your program.

Personal Information Protection Statement: Personal information is collected from you for the purpose of registering you as a home educator of your child/ren. The Office of the Education Registrar complies with the *Personal Information Protection Act 2004* which regulates the disclosure of personal information.

The Department for Education Children, and Young People and other educational entities such as non-government schools will be provided with **basic personal information** including *Student* name, residential address, postal address, date of birth, identifying gender and school history when a home education registration is granted, completed, revoked, or withdrawn. *Basic personal information* about the registered home educator (the home education applicant) will also be provided including name and other details such as a residential address, postal address, contact numbers and email address.

If you cease home educating or your child returns to school, please advise the Office of the Education Registrar in writing as soon as possible.
